Last year we completed 6,150 shoeboxes.

Individuals or businesses donating at least \$500 to AOI can receive up to 50% of that donation back as a tax credit. Individuals who

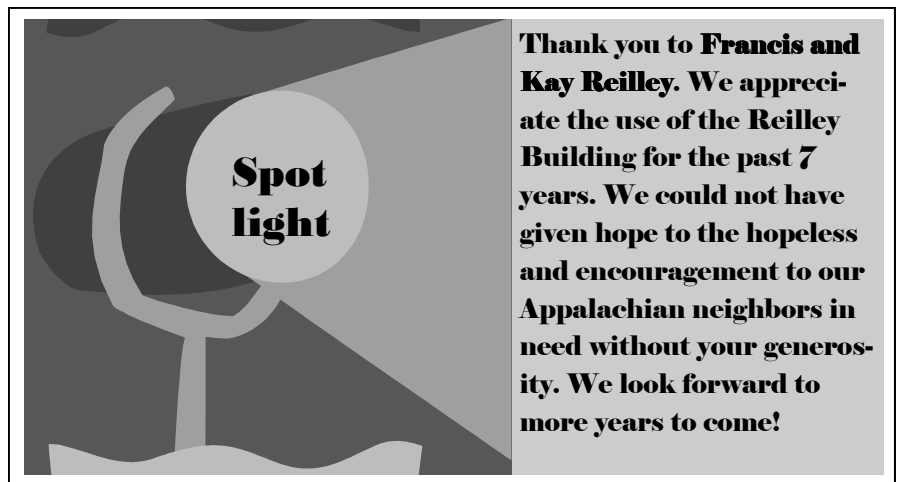
itemize donations on their federal income tax return may also qualify for additional federal tax savings.
