## Tax Savings Available Now Through NIP Vouchers!!!

Now that it's tax time, we want to remind you that a donation to AOI might help reduce your tax liability.

The West Virginia Development Office, through its Neighborhood Investment Program (NIP), has once again allotted tax credit vouchers to AOI. We have received \$21,243 in vouchers to be distributed on a first-come, first-served basis through June 2008.

Individuals or businesses do-

notating at least \$500 to AOI can receive up to 50% of that donation as a tax credit. These credit vouchers can be used to reduce state corporate net income, business franchise, and personal income taxes. The amount of the credit may be taken in one year or over a five-year period, beginning in the tax year in which the donation was made.

Eligible contributions to AOI for NIP tax credits can be in the form of person-

al check, real estate, and/or publically traded stock. Persons who itemize donations on their federal income tax return may also benefit from further tax savings.

With combined federal and state tax savings, a contribution to AOI could have a much smaller net cost to you, make a larger impact on the less fortunate, and significantly reduce your tax liabilities. Contact us (845-2762) for more details.
